Upon call of the President The trustees of the Association met at the house of R.A.Tawney. First business was to prepare estimates for a two string barbed wire fence to enclose cemetery grounds. Jos. Forsyth was delegated authority to purchase material for the same. August Lambrecht was authorized to build the fence and receive therefor three dollars (\$3.00). Deed for Cemetery grounds was accepted as acknowledged by August Lambrecht and wife and given the President to have recorded. Adjourned Sinedel.

Minutes of annual meeting. Pursuant to notice given, The members of Pleasant View Cemetery Ass'n met at the house of August Lambrecht. The President Jos. Forsyth called the meeting to order. first in order was reading of minutes of First meeting also minutes of Trustees meeting held Oct. 1st 1883 on motion the minutes of both meetings were approved. On motion August Lambrecht was elected Treasurer to serve for three (3) years. Jos. Forsyth to whom authority was given to receive donations with which to build cemetery fence and superintend the erection of same proceeded to render statement in connection with the said duty, said statement was accepted as correct and approved. Motion made and carried that the trustees be instructed to meet in Pierce on April 1st to acknowledge Deeds to all cemetery lots sold to this date. On motion adjourned Sine die. R.A.Tawney, Sect'y.

WILLOW CREEK PRECINCT. Mar 14th, 1885.

Minutes of meeting of members of Pleasant View Cemetery Association. Pursuant to notice Meeting was held at house of August Lambrecht, upon motion minutes of meeting held March 8th, 1884 was read and discussed and approved. Upon Motion R.A.Tawney was nominated and elected to the office of Secretary of this Association to serve three (3) years from the 1st Saturday in March 1885. On motion adjourned Sine Die.

WILLOW CREEK PRECINCT. March 7th 1890.
Minutes of Annual meeting.

Pursuant to notice the members of Pleasant View Cemetery Met at August Lambrecht house. as there had not been any meeting since March 5th and no officers elected. the members elected full board. Elected S.W.Kinkaid President for the term of one year; August Lambrecht Treasurer for the term of two years. and L.L.Poynter Secretary for the term of three years. The Treasurer to notify all parties owning for their lots to pay for them by the 1st of May 1890 if not to be sold for \$2.50. It was motioned and carried that S.W.Kinkaid to run the ground and see what is needed and make out a statement. and give John Broadbooks an order for the material. and 3 red cedar posts. and he is to get the material and he is to repair the work.
