MINUTES OF 2023 ANNUAL MEETING OF MEMBERS

The 2023 Annual Meeting of the Members of the Lambrecht Cemetery Association of Pierce County, Nebraska, was held on Sunday, October 1, 2023, at 1:00 p.m., in the Fellowship Hall of the United Church of Christ, 303 South Brown Street, Pierce, Nebraska 68767. A Notice of the 2023 Annual Meeting of the Members of the Lambrecht Cemetery Association of Pierce County, Nebraska, had been published prior to the meeting in the September 21, 2023, issue of the Pierce County Leader newspaper, a legal newspaper published in Pierce County, Nebraska. The Certificate of the Clerk with the attached Affidavit of Publication is attached.

The following Members/Trustee/Officers of the Lambrecht Cemetery Association were present for the 2023 Annual Meeting, to wit: Tom Kuether, Betty Leisner, Loren Lindahl, Jeff Ryan, Dori Walton, and Beth Peterson. The Clerk/Secretary, Loren, stated that Neb. Rev. Stat. §12-501(4) provides that a quorum of the Members of a cemetery association shall consist of four or more members of such association being present at a meeting of the members of the association. As four or more Members of the Lambrecht Cemetery Association are present, Loren, as Clerk, declared a quorum of the Members were present and all Members present waived the statutory notice requirement.

Tom, as President, called the Annual Meeting of the Members to order.

Clerk/Secretary's Report: Loren stated that the Minutes of the 2022 Annual Meeting of the Members had been previously emailed and also included within several prior Newsletters of the Lambrecht Cemetery Association. No corrections or revisions having been noted, Tom declared the Minutes approved. The Members' Directory was reviewed and updated. Dr. Larry and Mary Birch have the C1 Burial Space in Block 11; Linda Jelinek has the D7 Burial Space in Block 14; Carol Peterson is deceased and buried in Burial Space B 6 of Block 14; the Jimmy Synovec Burial Space at B7 of Block 16 is available for sale as he has determined to be buried elsewhere. It was also reported that Ronald and Sharylene Riedel wish to assign their two Burial Spaces at D3 and D4, Block 10 to Sharylene's sister, Roene Kruckenberg (D4), and for the interment of their recently deceased brother, Keith W. Otto (D3). Loren will be in contact with Sharylene and Roene to finalize this assignment. The updated Members' Directory is attached to these minutes. Loren also noted three issues of the Lambrecht Cemetery Newsletter were published since the last annual meeting. Loren also reported that a website has been created for the Lambrecht Cemetery at *lambrechtcemetery.com*. It is still a "work in progress." Comments and suggestions are welcome.

Treasurer's Financial Report: Dori, as Treasurer, presented the 2023 Treasurer's Report in written form. Dori also indicated that there had been two additional donations to the Lambrecht Cemetery Restoration Donations account as noted at the bottom of her report. The Treasurer's Report is attached to these Minutes. Betty made a motion to approve the 2023 Treasurer's Report. Tom seconded said motion. All Members voted yes. Tom declared the motion adopted. There was discussion reference investing some of the funds of the Lambrecht Cemetery Association into a Certificate of Deposit to gain a higher rate of interest. Dori stated that she would inquire at several banks as to CD interest rates and report back to the Trustees for a decision.

President's Report: Tom reported the internments, purchases, mowing, and liability insurance presently being maintained for the Lambrecht Cemetery. Since the 2022 Annual meeting on October 2, 2022, to present, the only burial in the Lambrecht Cemetery has been the interment of Carol Peterson. Kodi Kuether has been hired to mow the grasses of the Lambrecht Cemetery. He has mowed six times in 2023 and will continue to be employed for 2024 at a contract rate of \$125.00 per mowing with an additional fee/surcharge for an increase in fuel costs and/or clean up as necessitated and directed by the Trustees. The liability insurance policy for the Lambrecht Cemetery is with Farmers Mutual of Nebraska Insurance Company through the insurance agency of Town & Country Insurance in Pierce, Nebraska, and will be renewed for an additional year and the premium of \$50.00 paid accordingly. Tom was thanked for the removal of a large portion of the dirt pile in the southwest corner of the Cemetery. Tom stated also the Members' appreciation for the new entrance gate to the Cemetery. The frontage fence was also discussed. The initial thought was that the existing fence could be utilized but that new posts would enhance the appearance of the Cemetery. Dori stated that one existing post does have on it a finial the design of which could be incorporated

onto new posts for the frontage fencing. Dori stated that she and Rick would research the creation of those finials and posts. Loren also brought to the attention of the Members that there are several unmarked graves in the Cemetery. He suggested that if we know the name of the person buried in those unmarked graves, then the Cemetery Association, if the descendants of the person in the unmarked graves do not place a tombstone of the grave, should bear the cost of obtaining and placing a tombstone on those graves. Loren stated that he would investigate the number of unmarked graves and the costs associated with this project, and report back to the Members his findings.

Ratification: The Members then discussed a motion to ratify all prior acts and conduct of the Trustees/Officers of the Lambrecht Cemetery Association from October 2, 2022, to present. Dori made a motion to that effect, which was seconded by Beth. There being no further discussion, the Members of the Lambrecht Cemetery Association unanimously approved said motion and President Tom declared the motion adopted.

New business: The proposed Purchases/Restrictions; Rules/Regulations of the Lambrecht Cemetery Association were then reviewed and discussed. Jeff moved that the revised document be approved. Betty seconded the motion. All members present voted in the affirmative. Tom declared the motion adopted. The revised Purchases/Restrictions; Rules/Regulations are attached to these minutes. All Officers stated that they would not accept any monetary compensation for their services to the Lambrecht Cemetery Association though they would be entitled to be reimbursed for their out-of-pocket expenses. Also, the Trustees, as a whole, would agree to act as the Sexton of the Lambrecht Cemetery. The frontage fencing had previously been discussed in the meeting.

Operating Budget for 2024: After reviewing the financial condition of the Cemetery Association, and the estimated expenses for 2024, it was agreed by the Members that there would be no assessments due from the Members for payment of the expenses of the Cemetery for 2024. The Cemetery will continue to rely on donations from its Members, and others interested in the Cemetery, for payment of its continuing expenses.

Vacancies on the Board of Trustees: All Officers agreed to continue to serve until the next annual meeting of the Members. Loren stated that he would continue as Clerk/Secretary of the Lambrecht Cemetery Association till the next annual meeting of the Members but would thereafter resign from that position.

Matters for the good of the Association: Betty was thanked for arranging the meeting place of the annual meeting of the Lambrecht Cemetery Association at her church and allowing the Members to utilize the Fellowship Hall of the church for this meeting.

There being no further old or new business to discuss, all matters on the Agenda having been discussed and acted upon or passed over, the 2023 Annual Meeting of the Members of the Lambrecht Cemetery Association was adjourned by Tom at 1:50 p.m.

Purchases/Restrictions

- Burial Space Purchase: \$100.00 (Each Burial Space is 4.5 feet in width and 9 feet in length)
- Staking Fee for grave opening: No charge
- Staking Fee for headstone placement: No charge

The Lambrecht Cemetery Association reserves the right to sell Burial Spaces to private individuals only. Burial Spaces are for burial purposes only. Only one casket per Burial Space. A cremation urn may be placed on top of casket in the same Burial Space. No more than two cremation urns may be placed in one Burial Space.

Contact a cemetery trustee for sales and all burial information.

Please consider adding a permanent vase to mount on the tombstone or tombstone base when purchasing a tombstone or tombstone bench.

No mausoleums or other above ground burials permitted, with the exception of interment tombstones and benches.

Rules and Regulations

- Open dawn to dusk.
- Pet waste shall be picked up and removed immediately.
- Decorations must not hinder safety or obstruct maintenance and mowing of the cemetery.

The Lambrecht Cemetery Association reserves the right to remove any item that is offensive, inappropriate or unsightly. Any decoration, including live plants & trees, deemed to be an obstruction will be removed. The Association will not be held responsible for any discarded decorations or plantings, nor be held liable for loss or damage caused by an act of nature, theft or unavoidable accident.

These <u>Purchases/Restrictions</u> and <u>Rules and Regulations</u> may be amended without notice at any time.
